

## **Congratulations on the purchase of your Kineticco Water System.**

Kineticco Incorporated warrants its Water Softeners, Filters and Membrane Systems to be free from defects in material and workmanship according to the following terms and conditions:

### **What is Covered?**

Any faulty parts will be replaced at no extra charge for the part if it fails within the following time periods originating from the date of purchase of your system:

#### **I. Softeners**

**4** Four years on Compact Commercial Softeners, Commercial Plus Softeners and Kineticco Softeners

**3** Three years on Powerline™ Softeners

#### **II. Filters**

**4** Four years on Commercial Plus Filters and Kineticco Filters

**3** Three years on Powerline Filters

#### **III. Membrane Systems**

**1** One year on TQ Series Membrane Systems, TS Series Membrane Systems and TL Series RO Drinking Water Systems and Purifiers.

#### **IV. Deionization Systems**

**1** One year on HP Series Systems

#### **V. Vended Products**

Other Kineticco products, components and accessories that are not specifically mentioned elsewhere in this warranty [including but not limited to storage tanks, valves, pumps, filter housings and electrical controls] and/or not manufactured but distributed by Kineticco through authorized dealers, are covered for a period of one year from receipt.

*Warranty does not include freight or labor charges.*

### **Extension of Warranty to a Subsequent Installation**

The ORIGINAL OWNER may move the system to another location. The influent water quality at the subsequent location MUST, however, be within your system's operating specifications. Please contact a local authorized Kineticco dealer prior to installation at another location.

### **Limits on this Warranty**

Your system must be sold to you by an authorized Kineticco dealer in order to receive coverage under this warranty.

The design and performance of your Kineticco system is related to the chemistry of the water being treated; therefore, this warranty is limited to the equipment manufactured or distributed by Kineticco.

Warranty on the commercial reverse osmosis membrane does not include damage due to scaling, iron and bacterial fouling or freezing. Periodic replacement of filter cartridges and certain filter media (such as carbon, birm, calcite or Filter AG) is part of the normal maintenance required by your system. These replacements and media loss due to natural attrition are not covered.

This warranty does not include damage to your system due to:

- Abuse, misuse or neglect
- Excessive pressure (as specified on product's data sheet)
- Excessive water temperature (as specified on product's data sheet)
- Freezing, alterations or misapplication
- A change in the influent water characteristics
- Power surges
- Influent water conditions outside product data sheet specifications

*Your equipment must be installed and operated in accordance with Kineticco's recommendations, and applicable state and local codes.*

### **Registration and Service**

To place your system under warranty, the owner's registration card must be completed and one copy returned to Kineticco Incorporated P.O. Box 193, Newbury, Ohio 44065, within 30 days of the installation date. For service under this warranty, you should contact the dealer or Kineticco. Retain your copy of the owner's registration card along with this warranty for reference if service is necessary.

### **No Other Warranties**
